

AGREEMENT
with regard to PERSONAL DATA PROCESSING of the Participants
in the events of QilinGong School (FNQR)

I have been informed that the Operator processes my personal data in accordance with the applicable legal provisions, and that the processing complies with the data confidentiality and security regulations by means of the adequate technical and organisational measures implemented by the Operator.

1. The following information is considered personal data: name, surname, address, date of birth, personal number, e-mail, phone number, physical and mental health status, supplied to the Operator, according to the medical certificate.
2. I have been informed and I understand that the processing of the above mentioned personal data is for the purpose of my participation in events organized by **FNQR/ member associations/ trainers** and that I can be contacted by the above for the purpose of receiving messages and information related to the activities they organise, as well as invitations to participate in studies and/ or surveys.
3. I have been informed that **the legal basis** for collecting and processing of the above mentioned personal data for each of the mentioned purposes is represented by **my unequivocal consent**, acting as **person in question**.
4. I have been informed and I understand that the processing of the personal data will be operated as long as it will be necessary for the above mentioned purposes or for the period of time stated by the applicable legal provisions.
5. I have been informed and I understand that the personal data could be transferred to companies that could render services that are related to the purpose of personal data processing (e.g.: accounting, IT) or to authorities, based on the applicable legal provisions. I have been informed that the operator does not intend to transfer my personal data to the countries outside the European Economic Space.
6. I have been informed and I understand that I can exercise all **my rights** stated by the EU Regulation 2016/679, as follows:
 - **The right to access data**, respectively the right to receive from the operator a confirmation that they are/ are not processing personal data that involve me and, if my data is processed, to be granted access to the respective data and to the information provided by the law.
 - **The right to data correction**, respectively the right to receive from the operator, without reasonless delays, the correction of inaccurate personal data related to me.
 - **The right to data deletion**, respectively the right to receive from the operator the deletion of personal data related to me, without reasonless delays, under the conditions stated by the law.
 - **The right to containment of processing**, respectively the right to receive from the operator the containment of the processing, under the conditions stated by the law.
 - **The right to the portability of data**, respectively the right to receive personal data related to me and supplied to the operator in a structured format, frequently used and which can be automatically read, as well as the right to transfer this data to another operator.
 - **The right to opposition**, respectively the right to stand against at any time, based on reasons related to my particular situation, to my personal data being used for processing or profile creation, according to the law.
 - **The right to withdraw my consent** at any time and for any of the above mentioned purposes, without affecting the legality of the processing which had been operated on the basis of my consent before its withdrawal.
 - **The right to be notified** by the operator in case of breaches regarding data security.

These rights can be exercised by transmitting a written application, bearing date and stamp, which will comprise the formulated requests and the reasons therefor, to FNQR to the e-mail privacy@qilingong.com or by calling +40 774 586 343

7. Moreover, I have been informed that I have the right to address the National GDPR Authority or the competent Court of Law, for the defense of any of my rights granted by the EU Regulation 2016/679, that have not been respected.
8. I was informed that my refusal to provide my above-mentioned personal data triggers the impossibility of FNQR to contact me in this respect, to send me information regarding its activities, invitations to participate in studies and/or polls, etc.
9. If the provided personal data is not correct or if it should undergo any changes, I hereby take it upon myself to inform FNQR in writing thereof, and in due time.
10. In order to process the personal data of the participants that are not 16 years old, my consent as legal representative (parent, guardian) is requested.
11. My personal data is stored by the Operator or by partners of the Operator, specialized data storage service providers (hosting, cloud, etc), who offer legal guarantees in this respect. These do not hold the right to access the data, to intervene or to send it to third parties, with the exception of the operations requested by the Operator.
12. Upon the request of organizations or of competent authorities (supervising organizations, police, the Public Prosecutor's Offices, Courts of Law etc), personal data can be transmitted under the legal provisions.
13. As participant, I agree/ do not agree with being filmed, having individual and/or group photos taken during my participation at FNQR events, or/nor with their storage and publication, including online for the purpose of the presentation and the promotin of QilinGong.
14. The participant agrees/does not agree with having individual and/or group photos taken while participating in the FNQR events, or/nor with their storage and publication, including online, as can be determined based on the X/ tick marks in the tick-boxes from below:
